SCENT PERFQUE LTD CLP STATEMENT

New CLP Regulations:- We appreciate that many of you are struggling when it comes to the new rule that came in to force on 1st June 2015 and it has caused confusion and un-necessary stress for many consumers. We invested in the correct CLP software to make this transition as simple as possible for everyone.

So I am pleased to advise that we have made an executive decision to support you though this change by providing you with all the necessary documents you require, not just the standard SDS for the fragrance oils but this will also include SDS & Label information for the finished product based on maximum ratios of 10% Candles using Soya or Mineral Wax and 20% Diffusers using Augeo as the base.

However we also issue this Disclaimer statement below, in the event that formulations are change and ratios are increased beyond the maximum ratios that these documents cover.

SCENT PERFIQUE STATEMENT/DISCLAIMER

Please note that the attached information is provided in good faith and is to be based on our current knowledge of the CLP Regulations, which may be subject to change. Furthermore, it only represents the CLP contribution of the fragrance components and does not take into consideration any other ingredients that may be contained within the final product. The ultimate responsibility for the classification and labelling of the final product lies with the person placing it on the market. We recommend that this is determined using the information contained within the SDS of the neat fragrance in conjunction with that of the other ingredients within the final product.

CLP (European Regulations (EC) No 1272/2008 on Classification, Labelling and Packaging of substances and mixtures) actually came into force in 2009 (January) in all EU Member States, which also includes the UK. It was agreed by the EUL (European Union Level) that as from the 1st June 2015 these rules would apply including the UK. EN15494 provides some standardized fire safety warnings that most manufacturers choose to include, communicating perhaps the greatest risk posed by a candle.

CLP only applies to Home Fragrancing Products (**Not - Cosmetics**) which are classed under separate rules. CLP effects the following Products:- Reed Diffusers, Wax Melts, Scented Sachets, Room Spray, Candle etc. (Including any other products that may fall in to this category), As they are clacked as a mixtures, all allergen information supplied on the documents provided, should be present on you finished product label including any pictograms that may be relevant.

Many fragrances ingredients, are known eye/skin irritants, skin sensitizers or are environmentally hazardous substances, if present at concentrations above the cut-off values listed in section 16 on the MSDS, they trigger health or environmental warning statements and/or pictograms which should then be clearly stated on any labelling/packaging.
